

GOVERNMENT CONTRACT PROVISIONS

FAR/DFARS Clauses – The following clauses set forth in the Federal Acquisition Regulations (“FAR”) and Defense Federal Acquisition Regulations Supplement (“DFARS”) are incorporated herein as if set forth in full, unless the text of the purchase order expressly provides otherwise. If the date or substance of any of the clauses listed below is different than that in the current version of the Federal Acquisition Regulation (“FAR”) or one of the agencies supplements the date or substance of the clause in the current version of the FAR or the applicable agency supplement shall apply instead. :¹ If any of the following FAR provisions and clauses do not apply to this Purchase Order, such provisions and clauses are self-deleting.

Where necessary to make the referenced FAR/DFARS clauses applicable to this order, the following terms of the clause shall be modified: the term “Contractor” shall mean “Seller”, the term “Contract” shall mean this order, the term “Contracting Officer” or “Administrative Contracting Officer” shall mean “Buyer,” and the term “subcontract” and “subcontractor” shall mean “sub-subcontract” and “sub-subcontractor.” Seller will provide whatever reasonable assistance Buyer may require to maintain compliance between the order and any higher tier Government contract under which the order is issued.
